## \* RULES AND REGULATIONS:

# 1. Name of the Institutions

The name of the Institution shall be VISARHA JILLA MAYARIRMANA SAMITI herein after called the Saminan.

#### 2. Situation:

The Samit1 is situated at 27-4-67 Main Road,

# 3. Registered Offices

The Sangham will have its Registered office at 17.4-67 Main Road, visatheratom... It can also be shifted to any other place as and when found necessary by the Sangham. The error of operation of the santi shall be Visathapatham District.

4. The Programme of the Samiti shall be cerried by the following Bodies (1) General Body. (11) Board of rustees.

 The Board of Trustees ie., the Managing Committee shall consist of mine members, including the Office bearers.

#### 6. Membership:

The Membership shall be of the following categories, namely

(a) Individual; (b) Honorary-

## 7. (a) Individual Members

All persons shows the age of 21 years recognized by the Sasiti as bonaride members in the field of orandas and Rhooden movements thad and village Industries not engaged in any activity inconsistant with the salms and objects of the SasitiA, may, or application, be enrolled as members.

## (b) Honorary Member =

only such individuals, as in the opinion of the General Edy of the Semiti have been found qualified because of their distinguished services in the furthermore of the sims and objects, or so outstanding personalities whose membership, in the original the General Edy, shall add to the general prectige of the gast be invited by a situation and a special resolution of the General Body to join the Samitias and a fine order members.

(ii) All nominations for honorary membership shall be received by the Reard of rustees in the first lastance, who shall be competent to scrutinise the case / cases and recommend to the general Body such cases as in their unanimous opinion deserve consideration.

(iii) Honorary members will not enjoy all privileges available to individual members. They will act only as advisers to the Sangham.

# 8. Subscription for membership - Categorywises

a) All Life Members of the Samiti shall pay a membership fee of Mr.100/- towards their subscription. The membership shall commerce of the subscription amount of Mr.100/- in lumpais on payment of the shall of the ten monthly installent of Mr.100/- sech. All Trustees of the Samplam shall be Iffe Kenhoff hallo-sech.

b) In the case of individual members including artisans other than 1476 Hembers, they shall pay Re-1/- per month each, or give two houtes of handspun years per mouth.

- o) Membership fee shall be payable in advance at the beginning of every financial year and shall be payable within one mouth from the day of its falling due.
- d) Any member who fails to pay his subscription within three months from the due date will automatically cease to be a member and will lose his right to vote.
- e) The General Body shall however be competent to revise the rates of the membership subscription as deemed fit.
- f) Every application for nembership of a masher, other than the initial promoters, shall be made in the prescribed form accompanied by an admission fee, if any, that may be fixed by the Poard of Trustees, from time to time sand shall be addressed to the President of the Samith.
- g) All applications for membership shall have to be approved by the Boad of Trustees which reserves the right to admit of reject my application without assigning may reason whatever and whose decision shall be final.

h) The membership of a momber of any category shall be liable for termination by a simple majority vote of the General Body meeting on the report of the Board of Trustees that:

- the member has made default in the payment of membership fee for a period exceeding three months or that the behaviour of the member has been prejudicial or attrimental to the principles and objects of the Samiti.
- ii) In the case of the individual members and membership shall also be discontinued if the member
  - a) is proved to be below 21 years of age;
  - b) has been found to be of un sound mind;
  - has been convicted of a criminal charge involving moral turpitude;
  - d) is an undischarged insolvent.

## 9. SANGHAMS

All members of the samiti shall form into a Body, hereinafter known as VISAKHA JILLA NAVA NIRMANA SAMFI.

## 10. GENERAL HODY:

The General Body shall meet once in a year in the month of Tune. The Special General Body meeting can be earlier in Assessary. The Secretary shall give as far as possible, one mouth's motice for such a meeting amounting the date and venue of the meeting. It however such meeting is not convened by the Secretary, the Chaiman can, on requisition made by 3/5th members of the General Body, direct the Secretary to call for such meeting.

All mambers referred to in Clause 6 shall constitute the General Body of the Samiti and shall meet atleast once in a year to:

  - c) the meetings of the General Body, Board of Trustees shall be presided over by the President or in his absence by the Vice-President or in his absence by such member as may be elected for the purpose by the

These trustees will hold Office for the first five years, thereafter four Trustees out of the first nine trustees, as mentioned above, as may be determined by lot, shall retire, by rotation every three years and they'ir vacancies shall be fillein by the remaining Trustees. Such retiring Trustees will be eligible for renomination.

- c) The Board of Trustees shalls
- i) meet atleast once in three months. The quorum for condueting business in such meetings shall be four.
- ii) elect the Fresident, Vice-President, Secretary and Treasurer from out of its members who shall hold Office for a period of five years initially and after complation of the said term there shall be election, from out of the Trustees of President, Vice-President, Secretary and Treasurer, every three years by the Board of Trustees.
  - d)The Board of Trustees shall perform all transaction relating to the Smiti and its branches eg., Purchase, sale, mortgage, lesse of its proporties and to receive loans and stocks of goods;

- e) All policy matters releting to the utilisation of funds and other financial matters of the Samiti shall be decided by the Board of Trustees;
- f) The Board of Trustees shall have power to amoint such Sub-Cognitiess as and when uccessary to advise the Saniti on such matters as the Board of Frustees dean if mecosary. The Board of frustees have the power to coop any experts of their choice on such Committees on any subject on which such advice becomes useessary.

## 12. TERM OF OFFICE:

The Board of Trustees mentioned in the Memorandum of Association shall constitute the first of the Sanit! and its puriod of Office shall be five years.

## 13. CUORUM:

- a) The quorum for the General Body shall be 1/2 of its member s.
- b) The quorum of the Board of Trustees shall be four.

# 14. EXTRA-ORDINARY MEETING:

Extra-Ordinary meeting can be called for by the secretary of the requisition of the Free dont. Such a meeting shall also be called by the secretary of he receives a requisition to that effect signed by atleast 1/Srd of the total members on rolls of the Sattis within one month from the dots of receipt of the requisition.

#### 15. ORGANISATIONAL SET UP:

The Rules end Regulations necessary for the promotion and progress of the sativities of the Samiti shall be prepared by the Trust Board. The Trust Board shall be responsible for carrying on the Programme of north outlined by the Samiti and shall make proper arrangements for the organizational set up required for the purpose. The Board of Trustees shall have exthem they or the properties and finances of the institution.

- 16. Action Committee on behalf of the Samiti will have to be constituted to work actively for the quick and timely readisention of the special forms of assistance available to them from the State and Central Governments. The Action Committees would also assist the Samiti in securing the translational action of the special sefectors and the previous provided in the Constitution of India Act.
  - 17. The General Body shall have power to alter, amend or abridge the Rules and Regulations within the meaning of the constitution of the Sangham on the recommendation of Board of Trustees.

# 18. VALIDITY OF HENERSHIP:

If any member of the Trust Board absents himself/herself for a consequite meetings he/she shell rease to be the member of the Trust Board and shell loose right to vote.

10. DUTIES OF OFFICE REARRY: (a) RESTIDENT: The President shall preside over at leatings of the Symil; supervise all activities of the Smitt and give directions to the Secretary for the administration of the Smitt. In the absence of the President, the Vice-President of the Smitt shall preside over the meetings. In his absence the Foad of Trustees shall

(b) SECRETARY: The searchery shall convine the machings of the Board of Prushees as well as the meetings of the Executive Committee as provided for. He shall present the seconus and reports to the Board of Prushees, periodically, shall cause to maintain accounts and records, present the smuel reports and Balance sheets etc., to the Board of Prushees and to to the shelles and do every thing for the progress and furthersnee of the Smith. ## 20. REMOVAL OF MEMBERSHIP:

The Board of Trustees of the Samiti shall refuse membership to any body without assigning any reason what-so-ever.

A membar of the general Body can be expelled by the Board of Trustees in the event of member acting in a manuar projudicial to the objects or the rules and regulations of the santis.

## 21. ADJUSSION OF NEW MEMBERS:

ill applications received from institutions seeking admission into the symiti fulfilling the conditions prescribed by the Samiti shall be placed before the Board of Trustess which shall decide the great of membership.

#### 22. REPLACEMENT OF FILLING IN VACANCIES:

In case of vacancies arising by resignation, deth etc., in the Roard of Trustees, the Board of Trustees shall filling the vacancies by monitorion.

#### 23. APPROVAL OF RESOLUTIONS BY CIRCULATION:

If for any reason, the Board of Trustees cannot be convened to meet Resolutions of the Samiti can be sirewicked among the members of the Board of Trustees and their approval therefor obtained and incorporated in the minutes of its rest meeting.

If, however, a majority of members do not approve of the resolution the same should be placed before the next meeting of the Board of Trustees.

#### 24. AMENDMENTS TO RULES AND REGULATIONS:

The general Body shall have Power to make amendments to end alterations in the constitution and Bules of the Smuti as a meeting specially convened for the purpose by a 2/5 majority vote of the member greent and voting provided that such amondments and alterations to the constitution and rules are not inconsisted and incompatible with the aims and objects of the Smith or the spirit underlying the same. Such Resolution shall become operative only when it is once agging fillinged as mother subsequent meeting of the guern ledy, converse for the purpose after an interval of one month after the passing of the Resolution in the first meeting.

25. The General Body shall have power to approve Rules from time to time for the proper conduct of the sfrairs of the sendal
